



## Data on Revenue versus Expenditures for Canadian Registered Charities from 2000 - 2009

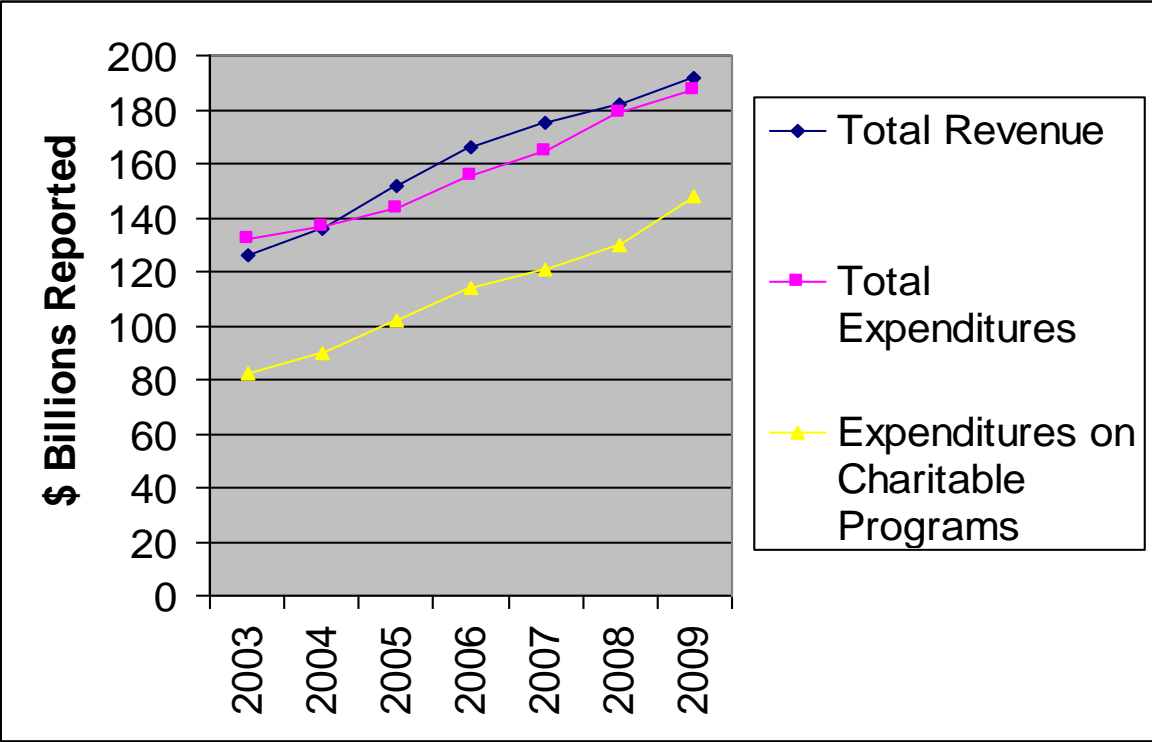
Here is an analysis done by the Charities Directorate of CRA around February 2011 on the revenue versus expenditures by Canadian registered charities.
